WHAT IS PREDATORY BEHAVIOUR?


PREDATORY BEHAVIOUR for the purpose of this workshop describes the situation when one NA member takes advantage of another NA member using disproportion of power to achieve personal gains or profit. This may include but is not limited to sexual harassment or predation.



CAN YOU GIVE AN EXAMPLE OF PREDATORY BEHAVIOUR?

Predatory behaviour is in direct conflict with our primary purpose as stated in Tradition 5.

We are here to see what is our role in solving this challenge as NA members and groups.



LET'S NOT FORGET...

• This issue may not affect us all personally or equally, but

it does affect our groups and NA as a whole (see Traditions 1, 4 and 12)

Our first experiences in and around meetings are critically important to our recovery

 New and returning members are especially vulnerable to being taken advantage of

 Not only newcomers or members who are preyed on are affected



LET'S NOT FORGET...

 Not every problematic behaviour is predatory behaviour, even if it may be problematic for group or members

- **o** Love is not forbidden in NA
- **OALL of us come to NA with issues**



LET'S NOT FORGET...

- We should carefully inspect our own motivations: Am I the best person to show this newcomer the ropes? Have I thought about the potential consequences of my actions? Is the arrangement we are about to make safe and beneficial for our recovery?
- We have a right to set boundaries no matter what we are all responsible for deciding who we let into our lives
- As NA members we are all responsible for creating the environment for safe recovery


WHAT THIS WORKSHOP ISN'T

- When dealing with these issues we should focus on solutions – not problems or particular addicts
- Workshop is not meant to divide members into victims and predators – we aim for unity
- No one can "kick someone out of NA" as per Tradition 3, but...





We should be clear to all addicts: You are welcome. Behaviour that harms others or disrupts the atmosphere of recovery is not welcome.





What can be done in this situation by the affected person? Other NA members? Trusted servants? The group?

SITUATION 1 | GROUP 1 **Experienced NA member** is constantly seducing newcomers met during the meetings. These people often do not return to NA meetings after being taken advantage of.

SITUATION 2 | GROUP 2

What can be done in this situation by the affected person? Other NA members? Trusted servants? The group?

NA member manipulates other members into giving them money after the meeting.

SITUATION 3 | GROUP 3

What can be done in this situation by the affected person? Other NA members? Trusted servants? The group?

Few NA members tricks other meeting attendants into working and buying from company that is in fact pyramid scheme. These members give other member's personal information to their co-workers so they can use it to sell the products.

What can be done in this situation by the affected person? Other NA members? Trusted servants? The group?

SITUATION 4 | GROUP 4

During a meeting, a member that has recently come back after a relapse is touched by another participant in a way that is disturbing for them. When they say it out loud, some members laugh, and the person identified as disruptor says: "I'm pretty sure you must still be using to imagine something like that".

What can be done in this situation by the affected person? Other NA members? Trusted servants? The group?

SITUATION 5 | GROUP 5

During a break, some NA members approach a newcomer and start convincing them that they'll never get clean if they don't believe in **Christ. But they surely** can help with that.

SITUATION 6 | GROUP 6

What can be done in this situation by the affected person? Other NA members? Trusted servants? The group?

During an online meeting, an addict with just a couple of months clean-time receives private messages on the chat – the other NA member comments on their looks and proposes contact outside of the meeting.

What can be done in this situation by the affected person? Other NA members? Trusted servants? The group?

SITUATION 7 | GROUP 7

During a meeting new NA member mentions being asked to clean their sponsor's house in exchange for sponsorship. In response to that some members share their difficult stories from sponsorship relationships – some were asked for money or favours by their sponsors, and someone is convinced that they can be sponsored by their lover as long as this person has much more experience in the program.



"We strongly discourage any harassment, threats, or disturbing behaviour before, during, and after our meetings. This includes unwelcome sexual, romantic, financial, and religious solicitation. Our meetings are for sharing NA recovery. If you feel harassed or threatened, share your concerns with the meeting leader or a trusted servant."

"There are times when action is necessary to protect members from danger, but when problems are resolved without crisis or disrespect, NA demonstrates its difference from the places we came from."

Traditions 1, 3, 5 and 12 tell us that:

- All of us are NA members trying to stay clean a day at the time
- Carrying the message is our primary purpose
 We must do everything we can to promote the atmosphere of recovery where everyone is safe to attend our meetings and that we are able to get what we came for recovery
