Our 5th Tradition says:


"Each group's single primary purpose is to carry the message to the addict who still suffers."

with possible options that can be combined







THE SWEDISH REGION



- We are around 230 groups that holds about 480 meetings each week.
 The groups consists of 15 areas, one of the areas is online.
 Our areas roughly have 6 ASC (Area service committee) meetings each year.
- The areas do the service that the groups can't do by them self, and the region do the service that the areas can't do by them self.
- The GSR, representing a group at the ASC votes for his or her group in matters regarding the area.
- The RCM representing a area at the RSC votes for his or her group in matters regarding the region.
- Our region has a Steering Committee, Nomination committee, Translation committee and a translation committee. We have Public Relations (OR) that organize our recording committee, Social Media committee with Info mail, our Helpline and Web committee.



Service Material Functions

- GWSNA Provides useful information about our service structure, service bodies, WSC, World Convention and much more. It is updated every 2 years in line with the WSC cycle. This is very useful for delegates!
- GLSNA Provides useful information about our service structure, particularly on a local level. This is good to use within groups, areas, regional meetings for reference!

- CAR Includes items for fellowship discussion and decision, including reports, proposals, and motions from the WB and any motions submitted from regions. The report contains the proposals and motions that the Fellowship is being asked to consider and form a fellowship-wide conscience on.
- CAT contains a variety of material to be considered at the upcoming WSC that was not included in the CAR. Items that typically are included in the CAT include the proposed NAWS Budget and project plans for the upcoming cycle, seating requests, and recommendations from the WB, as well as other service- or WSC-related material.
- **FIPT** A set of documents describing how NA's literature and logos are managed and protected for the greatest benefit of the fellowship as a whole. Contains its own glossary of terms. Approved by the fellowship in April 1993.

- The EDM is a European-based Forum of multilingual and multicultural NA communities, whose mission is to further their common welfare and unity, discuss issues of mutual concern, exchange ideas, and share experiences to further their primary purpose of carrying the NA message to the still-suffering addict.
- EDM is a Non-profit Association. The association was set up to help the body function legally as a Zonal Forum of Narcotics Anonymous.
- The EDM does not have a service office as such. Our legal association is based in Brussels and our address is the same as the NA World Service Office in Europe.
- EDM is one of 14 Zonal Forums of Narcotics Anonymous, which exists throughout the whole world. Zonal Forums provide an opportunity for World Service and World Board to better understand the needs and challenges of NA communities.

Why Planning?

- Planning helps us better carry the message to the addict who still suffers. Planning helps any service committee come together to determine where services are most needed and decide how best to move toward agreed upon goals.
- When there is no planning, often a service body will move forward in a status quo fashion—"this is the way we have always done it" may be the theme song. And with this theme song, service bodies may find that their committees do not work together with each other and the rest of the fellowship.
- Whether the service body is an area, region, or zone, we encourage members to use the planning process.

Key topics for Planning

- 1. Gathering information
- 2. Listing the issues
- 3. Developing goals (identify "what," not "how")
- 4. Prioritizing goals
- 5. Creating approaches (actions to reach goals)
- 6. Prioritizing approaches (a second look)
- 7. Developing an action plan

SAMPLE PLANNING SESSION AGENDA

Focus on task 20 minutes

- o Review planning session purpose, format, and anticipated outcomes.
- Review NA Vision Statement, ASC purpose statement, traditions, and concepts.
- Briefly discuss the future of the area and the effect the area can have on the members, groups, and community at large.

Develop issues 45 minutes

- o Review, clarify, and discuss the information from the area inventory.
- Create broad categories—list issues.

Set goals 45 minutes

- Set goals for each issue identified.
- Prioritize goals.

Develop approaches

45 minutes


- o For each goal, review and evaluate current area services and activities.
- Brainstorm new items.
- Create and write down approaches for each goal.
- Prioritize strategies under each goal.

Take next steps 30 minutes

- Discuss what steps need to be taken to document information and approve the area plan.
- Identify next steps to: 1) prepare for plan implementation, including determining subcommittees and workgroups needed, 2) assign goals to subcommittees and workgroups, and 3) develop work plans.
